M/s Wayanad Granites was obtained with the Environmental Clearance (EC) by State Environmental Impact Assessment Authority on 29-12-2017. As part of general condition No.37 of Environmental Clearance order and EIA Notification the half yearly compliance report needs to be submitted by the project proponent.

To reduce noise level in the project site, the project proponent has implemented mitigate masseurs. The major noise generating sources from the quarry are:-

- Drilling by Jack hammers
- Blasting
- ➤ Breaking by JCB/Hitachi
- > Transportation

The following control measures are undertaken to bringing down the noise levels:-

- Proper maintenance of machinery and equipments
- Controlled blasting technique is adopted in this project in order to reduce blast vibrations.
- 12 activities Quarrying should be limited to day **KSPCB** time as per guidelines/specific conditions.

To reduce the adverse impact of the local quarry to the community, quarrying activities are limited to day time only as per KSPCB guidelines.

A licensed person should The project proponent has appointed Second class manager and Mining Mate in the site to supervise/control exploitation of minor minerals including blasting at the project site. All activities of licensed persons are under the supervision of Environment Monitoring Cell. The certificate of mining mate is attached as **Annexure No.9 &** certificate of Second class manager is attached as **Annexure No.10**. The project proponent also appointed the persons with first Aid Certificate and it is attached as **Annexure no. 11**.

Access roads to the quarry shall be tarred to contain dust emissions that may arise during transportation of materials.

To contain dust emissions and for the trouble free transportation of materials, the project proponent has tarred the access road to the quarry site and maintaining in good manner. The project proponent splashes water on the road to arrest the dust production during summer season.



16 Overburden materials should be managed within the site and used for reclamation of mine pits as per mine closure plan/ specific conditions.

Overburden is an inevitable byproduct of building stone quarry. The overburden materials are stored within the site at designated place. This will be used to restore the exploited area in future.

All mining activities are progressing under the supervision of qualified personals. To enhance safety and to make environment friendly quarrying, the excavation activity in the project is progressing by creating benches of 5m width x 5m height

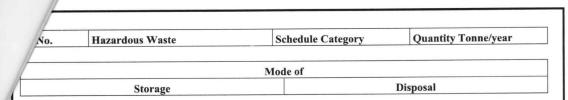

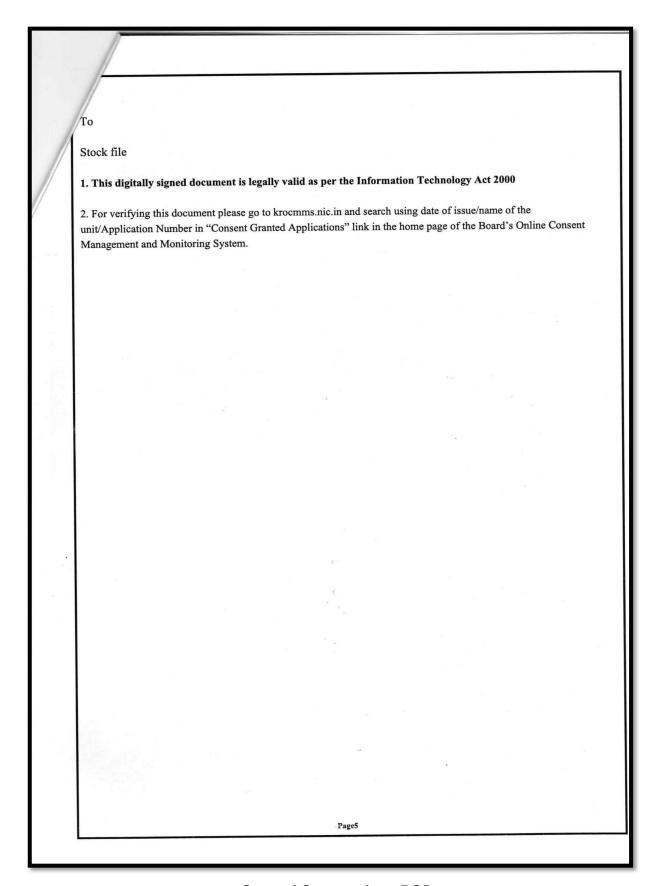

The stone quarry mine will result in increase in frequency of blasting for mining the mineral. However, controlled blasting with optimum charge of holes will be carried out to loosen the rock. Explosion hazards are envisaged due to mishandling of explosives. Explosives will be handled with utmost care in compliance of conditions imposed by Chief Controller of Explosive & Metalliferous Mines Regulation, 1961.

2. The proposal was placed in the 76<sup>th</sup> meeting of SEAC held on 25<sup>th</sup>& 26<sup>th</sup> July, 2017. The Committee appraised the proposal based on the Mining Plan, Pre-feasibility Report and all other documents submitted along with Form1.

The proponent agreed to set apart Rs 10 lake per annum (recurring) for CSR activities for the welfare of the local community in consultation with the local Panchayat. The Committee decided to defer the item for field inspection.

Site visit was conducted on 21.10.2017 by Subcommittee consisting of Dr.Khaleel Chovva & Dr.E.A.Jayson and submitted report

The land for the quarry project is private owned land and is possessed in the name of M/s Wayanad Granites. The targeted production of mine will be 1,00,000 MTA. The estimated project cost is about Rs. 3.35 Crores. The expected life of mine estimated will be about 11 years. The mining operation will be carried out by opencast semi-mechanized method as per the approved Mining Plan.

The proponent and partners were present when the team visited the quarry. The quarry is not working presently. Malabar Wildlife Sanctuary is about 8 km, SW and nearest town Kalpetta is about 5km. This quarry is working in partnership mode. Kabani River is about 4 km from the site. There are four quarries (not working) i.e., Mr. Thomas O.D., Mr. Joseph P.M. & M/s Krishnagiri Stone Crusher (2 quarries) were working with short term permit located within 500m radius and currently there is no working quarry near the site.

No important eco sensitive areas or forests is present within 100m. On field visit, it is suggested that, it is necessary to take precaution to avoid effluent waters entering the nearby areas. This calls for establishing scientifically laid garland drains and settling tanks for settlement of debris. The presently provided pits (two nos.) has to be developed into two settling ponds with sufficient depth with rubble lined side walls. Only filtered water after sedimentation be allowed to flow out of the quarry. The nearby house is located at a distance of 102 meters. Quarters and canteen facility has to be created before the functioning of the quarry. The boundary pillars has to be painted with yellow colour and lat.long. marked on the pillars. Tree planting as per the mining plan to be strictly followed. The application may be favourably considered.

- 3. The proposal was placed in the 81<sup>st</sup> meeting of SEAC held on 30<sup>th</sup> & 31<sup>st</sup> October, 2017. The proposal was appraised by SEAC after considering Form I, Form IA, Conceptual plan, field visit report and all other documents and details provided by the proponent and decided to **Recommend for issuance of EC** subject to general conditions in addition to the following specific condition.
  - 1. If any rare, endemic and threatened plant species are noticed, they shall be properly protected insitu or transplanted to a suitable site inside the lease area
- 4. The proposal was considered in the 76<sup>th</sup> meeting of SEIAA held on 16<sup>th</sup> November 2017. The Authority decided to issue EC subject to the submission of the copy of proof for having applied for Wild Life Clearance, with general conditions and the following specific conditions.
  - If any rare, endemic and threatened plant species are noticed, they shall be properly protected insitu or transplanted to a suitable site inside the lease area
  - All condition suggested by the field inspection report as noted above should be strictly implemented before starting mining.

# GENERAL CONDITIONS (for mining projects)

- 1. Rain Water Harvesting facility should be installed as per the prevailing provisions of KMBR / KPBR, unless otherwise specified.
- 2. Environment Monitoring Cell as agreed under the affidavit filed by the proponent should be formed and made functional.
- Suitable avenue trees should be planted along either side of the tarred road and open parking areas, if any, including of approach road and internal roads.
- Maximum possible solar energy generation and utilization shall be ensured as an essential part of the project.
- Sprinklers shall be installed and used in the project site to contain dust emissions.
- Eco-restoration including the mine closure plan shall be done at the own cost of the project proponent.
- 7. At least 10 percent out of the total excavated pit area should be retained as water storage areas and the remaining area should be reclaimed with stacked dumping and overburden and planted with indigenous plant species that are eco-friendly, if no other specific condition on reclamation of pit is stipulated in the E.C.
- 8. Corporate Social Responsibility (CSR) agreed upon by the proponent should be implemented
- 9. The lease area shall be fenced off with barbed wires to a minimum height of 4ft around, before starting of mining. All the boundary indicators (boards, stores, markings, etc) shall be protected at all times and shall be conspicuous.
- Warning alarms indicating the time of blasting (to be done at specific timings) has to be arranged as per stipulations of Explosive Department.
- 11. Control measures on noise and vibration prescribed by KSPCB should be implemented.
- 12. Quarrying activities should be limited to day time as per KSPCB guidelines/specific conditions.
- 13. Blasting should be done in a controlled manner as specified by the regulations of Explosives Department or any other concerned agency.
- 14. A licensed person should supervise/ control the blasting operations.
- 15. Access roads to the quarry shall be tarred to contain dust emissions that may arise during transportation of materials.
- Overburden materials should be managed within the site and used for reclamation of mine pit as per mine closure plan / specific conditions.
- 17. Height of benches should not exceed 5 m, and width should not be less than 5 m, if there is no mention is the mining plan/specific condition.
- 18. Mats to reduce fly rock blast to a maximum of 10 PPV should be provided.
- 19. Maximum depth of mining from general ground level at site shall not exceed 10m
- No mining operations should be carried out at places having a slope greater than 45°.
- 21. Acoustic enclosures should have been provided to reduce sound amplifications in addition to the provisions of green belt and hollow brick envelop for crushers so that the noise level is kept within prescribed standards given by CPCB/KSPCB.
- 22. The workers on the site should be provided with the required protective equipment such as ear muffs, helmet, etc.
- Garland drains with clarifiers to be provided in the lower slopes around the core area to channelize storm water.
- 24. The transportation of minerals should be done in covered trucks to contain dust emissions.
- 25. The proponent should plant trees at least 5 times of the loss that has been occurred while clearing the land for the project.
- Disposal of spent oil from diesel engines should be as specified under relevant Rules/ Regulations.
- Explosives should be stored in magazines in isolated place specified and approved by the Explosives Department.
- 28. A minimum buffer distance of 100m from the boundary of the quarry to the nearest dwelling unit or other structures, not being any facility for mining shall be provided.

- 29. 100 m buffer distance should be maintained from forest boundaries.
- Consent from Kerala State Pollution Control Board under Water and Air Act(s) should be obtained before initiating mining activity.
- 31. All other statutory clearances should be obtained, as applicable, by project proponents from the respective competent authorities including that for blasting and storage of explosives.
- 32. In the case of any change(s) in the scope of the project, extent quantity, process of mining technology involved or in any way affecting the environmental parameters/impacts as assessed, based on which only the E.C is issued, the project would require a fresh appraisal by this Authority, for which the proponentshall apply and get the approval of this Authority.
- 33. The Authority reserves the right to add additional safeguard measures subsequently, if found necessary, and to take action including revoking of the environment clearance under the provisions of the Environment (Protection) Act, 1986, to ensure effective implementation of the suggested safeguard measures in a time bound and satisfactory manner.
- 34. The stipulations by Statutory Authorities under different Acts and Notifications should be complied with, including the provisions of Water (Prevention and Control of Pollution) Act, 1974, the Air (Prevention and control of Pollution) act 1981, the Environment (Protection) Act, 1986, the Public Liability (Insurance) Act, 1991 and EIA Notification, 2006.
- The project proponent should advertise in at least two local newspapers widely circulated in the region, one of which (both the advertisement and the newspaper) shall be in the vernacular language informing that the project has been accorded Environmental Clearance and copies of clearance letters are available with the State Environment Impact Assessment Authority (SEIAA) office and may also be seen on the website of the Authority at www.seiaakerala.org. The advertisement should be made within 10 days from the date of receipt of the Clearance letter and a copy of the same signed in all pages should be forwarded to the office of this Authority as confirmation.
- A copy of the clearance letter shall be sent by the proponent to concerned Grama Panchayat/
  District Panchayat/ Municipality/Corporation/Urban Local Body and also to the Local NGO, if
  any, from whom suggestions / representations, if any, were received while processing the
  proposal. The Environmental Clearance shall also be put on the website of the company by the
  proponent.
- The proponent shall submit half yearly reports on the status of compliance of the stipulated EC conditions including results of monitored data (both in hard copies as well as by e-mail) and upload the status of compliance of the stipulated EC conditions, including results of monitored data on their website and shall update the same periodically. It shall simultaneously be sent to the respective Regional Office of MoEF, Govt. of India and also to the State Environment Impact Assessment Authority (SEIAA) office.
- 38. The details of Environmental Clearance should be prominently displayed in a metallic board of 3 ft x 3 ft with green background and vellow letters of Times New Roman font of size of not less than 40. Sign board with extent of lease area and boundaries shall be depicted at the entrance of the quarry, visible to the public
- 39. The proponent should provide notarized affidavit (indicating the number and date of Environmental Clearance proceedings) that all the conditions stipulated in the EC shall be scrupulously followed.
- 40. No change in mining technology and scope of working should be made without prior approval of the SEIAA, No further expansion or unodifications in the mine shall be carried out without prior approval of the SEIAA, as applicable.
- 41. The Project proponent shall ensure that no natural water course and/or water resources shall be obstructed due to any mining operations. Necessary safeguard measures to protect the first order streams, if any, originating from the mine lease shall be taken.
- 42. Monitoring of Ambient Air Quality to be carried out based on the Notification 2009, as amended from time to time by the Central Pollution Control Board. Water sprinkling should be increased at places loading and unloading points & transfer point to reduce fugitive emissions.
- 43. The top soil, if any, shall temporarily be stored at earmarked site(s) only for the topsoil shall be used for land reclamation and plantation. The over burden (OB) generated during the mining operations shall be stacked at earmarked dump site(s) only. The maximum height of the dumps shall not exceed 8m and width 20m and overall slope of the dumps shall be maintained to 45°. The OB dumps should be scientifically vegetated with suitable native species to prevent erosion and surface run off. In critical areas, use of geo textiles shall be undertaken for stabilization of the dump. The entire excavated area shall be backfilled. Monitoring and management of rehabilitated areas should continue until the vegetation becomes self-sustaining.

- Catch drains and siltation ponds of appropriate size shall be constructed around the mine working, mineral and OB dumps to prevent run off of water and flow of sediments directly into the river and other water bodies. The water so collected should be utilized for watering the mine area, roads, green belt development etc. The drains shall be regularly desilted particularly after monsoon and maintained properly.
- 45. Effective safeguard measures such as regular water sprinkling shall be carried out in critical areas prone to air pollution and having high levels of PM<sub>10</sub> and PM<sub>2.5</sub> such as haul Road, loading and unloading points and transfer points it shall be ensured that the Ambient Air Quality parameters conform to the norms prescribed by the Central Pollution Control Board in this regard.
- 46. Fugitive dust emissions from all the sources should be controlled regularly. Water spraying arrangement on haul roads, loading and unloading and at transfer points should be provided and properly maintained.
- 47. Measures should be taken for control of noise levels below 85 dBA in the work environment.
- 48. A separate environmental management cell with suitable qualified personnel should be set-up under the control of a Senior Executive, who will report directly to the Head of the Organization.
- 49. The funds earmarked for environmental protection measures and CSR activate should be kept in separate account and should not be diverted for other purpose. Year wise expenditure should be reported to the State Environment Impact Assessment Authority (SEIAA) office.
- 50. The Regional Office of MOEF & CC located at Bangalore shall monitor compliance of the stipulated conditions. The project authorities should extend full cooperation to the officer (S) of the Regional Office by furnishing the requisite data/information/monitoring reports.
- 51. Any appeal against this Environmental Clearance shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
- Concealing the factual data or submission of false/fabricated data and failure to comply with any
  of the conditions mentioned above may result in withdrawal of this clearance and attract action
  under the provisions of Environment (Protection) Act, 1986.
- 53. The SEIAA may revoke or suspend the order, for non implementation of any of the specific or thisimplementation of any of the above conditions is not satisfactory. The SEIAA reserves the right to alter/modify the above conditions or stipulate any further condition in the interest of environment protection.
- 54. The above conditions shall prevail notwithstanding anything to the contrary, in consistent, or simplified, contained in any other permit, license on consent given by any other authority for the same project.
- 55. This order is valid for a period of 5 years or the expiry date of mine lease period issued by the Government of Kerala, whichever is earlier.
- 56. The Environmental Clearance will be subject to the final order of the courts in any pending litigation related to the land or project, in any court of law.
- 57. The mining operation shall be restricted to above ground water table and it should not intersect ground water table.
- All vehicles used for transportation and within the mines shall have 'PUC' certificate from authorized pollution taking centre. Washing of all vehicles shall be inside the lease area'
- 59. Project proponent should obtain necessary prior permission of the competent authorities for drawal of requisite quantity of surface water and ground water for the project.
- 60. Regular monitoring of flow rates and water quality upstream and downstream of the springs and perennial nallahs flowing in and around the mine lease area shall be carried out and reported in the six monthly reports to SEIAA.
- 61. Occupational health surveillance program of the workers should be under taken periodically to observe any contractions due to exposure to dust and take corrective measures, if needed.
